1. Minutes

- 1. Meeting was started by Ms. Marta Slavíková, the director of the EGTC TRITIA. She stressed that consultation of a project outputs with stakeholders is a necessity because the project partners get feedback. She also stated that the organizer selected the venue of the seminar is symbolic, and she named it to a certain extent as one hubs for transnational cooperation. She informed too, there are preparing the presentations of projects progress with representatioves of the self-governing regions in each of headquaters of region separately.
- 2. Mr. Krawucka, Project Manager of the TRANS TRITIA Project shortly presented the main goals of the Project and progress of its activities, stressed the disscus with stakeholder is very important to elaborated of its outputs.
- 3. Mr. Santarius, Project Manager of the PP3 as the leader WPT2 (LofT2), presented the content and tasks of the project within WPT2, i.e. the development of Action Plans inland waterways, railway and logistics centers/terminals. He briefly described the content of the completed the Action Plan Inland waterways (A T2.1.) and outlined the processing of the AP Logistic Centers/Terminals, i.e. the subject of today's seminar. He thanked for the interest of the stakeholders present at the meeting and their contributions to elaborating the Action Plan.
- 4. Mr. Komínek presented detailed draft of the prepared reports D.T2.3.1 and D.T2.3.2 with charts, which compare density of terminals in European countries. Idea of three main themes of intermodal action plan was mentioned.
- 5. The points of view of the logistic operator, municipalities and scientific institutions was presented by follow speakers:
 - Mr. Vladimír Fišer, CEO of the BohemiaKombi of the "Freight villages in Germany"
 - Mr. Peter Danišovič, Head of Transport Research Center, University of Žilina of the "Intermodal center TIP Žilina"
 - Mr. Dariusz Polowy, Lord Mayor of City of Racibórz of the "Waterway Odra local and global view", comparing existing terminal Magdeburg to planned terminal Raciborz. He stated the City of Racibórz has a potencial to joint to activities of development of the intermodal transport / e.g. in connection with the planned construction of the Oder waterway/. "If is there a opportunity, it should be



used" he said, but he added too that he is aware that the preparation would be several years.

- Mr. Grzegorz Utracki, Mayor of the Municipality of Krzyżanowice presented the viewpoint of municipality - it is possible to weigh in cooperation with the City of Racibórz on the location of a multimodal logistics center at the border of both communities. He also presented the possibility of considering the location directly at the Odra river, where there is a place/space with connection to road and rail, and ultimately also by Odra waterway.
- Ms. Marzena Kramarz and Ms. Edyta Przybylska, Silesian University of Technology, Gliwice – TRANS TRITIA, Intermodal logistic terminals in Poland, present and future.
- 6. After Lunch was presented the next stakeholders view of thema logistic. There were presentations by:
 - Mr. Jiří Kalenský, Ministry of Transport, Railway and Water Transport Section Combined transport in Czech Republic
 - Mr. Robert Goc, Business Development Director, Śląskie Centrum Logistyki S.A. Śląskie Centrum Logistyki S.A. "Intermodal logistic terminal – present and future"
 - Mr. Michal Kubíček, Director of the Paskov Terminal, AWT a.s. Increasing of intermodal transport in Moravian – Silesian region according to the example of terminal Paskov
- 7. Disscussed questions:
 - <u>Śląskie Centrum Logistyki</u>. Currently status quo of the multimodal transport railwater of coal to Wrocław? This year, transport has not yet taken place, but it is believed that approximately 500 ships with a load of 500 tonnes will be transported by the end of the year. Transhipment capacities are planned to be expanded to an annual capacity of over 1 million tonnes.
 - <u>Advanced World Transport.</u> Are there any possibilities of further developments? The Paskov Terminal is using of 100% capacity and is preparing of s further expansion of infrastructure and network connections. The Terminal seems an ideal place to operating of the industrial zone due to the available distance to the industrial zone Hrabová 2 km by air and 4 km by the D56 motorway.
 - <u>PKP Cargo.</u> What is the situation with the using of trains of lenght of 750 m in the direction to the Gdańsk Sea Port (from Ostrava to PL-CZ border it is possible)? Representatives of PKP informated about currently limit of 600m and there is not aware of the date to using the lenght of 750m.



- CENTRAL EUROPE TRANS TRITIA
 - <u>KK-Terminale</u>. When are expect a finish of investition of Inland port / terminal in Kędzierzyn-Koźle? The representative of KK Terminale informed about the blocking of the connection of the terminal to the railway line, when the affected subjects do not communicate with the terminal. It is not possible to use the investments made, the deadline for unblocking the situation is unknown.
 - Mr. Komínek asked the present stakeholders, whether any of terminals has a
 potential and spacial possibilities to become a commodity center
 as presented Mr. Fišer (BohemiaKombi) in his speech. Czech stakeholders stated
 the Paskov Terminal together the Hrabová zone is slowly becoming
 a commodity center by natural development.
 - 8. Regional media have accepted the invitation to the meeting. In the meeting with the media the MFDnes (Press), Český rozhlas Ostrava (radio), and Česká Televize Ostrava (TV). MS. Izabella Wołłejko Chwastowicz, General Consul of Poland in Ostrava, Ms. Alexandra Krawucka, Project Manager of TRANS TRITIA Project, Mr. Pavel Santarius, organizer of this meeting PP3) and representatives of the stakeholders: Ms. Marta Sláviková (EGTC TRITIA), Mr. Vladimír Fišer BOHEMIAKOMBI spol.s r.o. and Mr. Dariusz Polowy (City of Racibórz).
 - 9. Ms. Izabella Wołłejko-Chwastowicz, the General Consul of Poland in Ostrava, at the end of the meeting emphasized the importance of cross-border dialogue, the mutual exchange of information or coordination of activities in the border area. She stressed that it was her pleasure to host this working team and again declared that the Consulate is / will be open to such activities.
